COMPLIANCE BY THE COMPANY OF THE WAIVER CONDITIONS IN RELATION TO THE EXTENSION OF TIME TO COMPLY WITH 705(3)(B)(II) OF THE MAINBOARD RULES IN RESPECT OF THE ANNOUNCEMENT OF 1H2023 UNAUDITED CONDENSED INTERIM FINANCIAL STATEMENTS

Reference is made to the announcement made by TA Corporation Ltd. (the "Company") on 15 August 2023 in relation to the grant of an extension of time by SGX RegCo for the Company to comply with Rule 705(3)(B)(II) of the Mainboard Rules in relation to the announcement of its 1H2023 financial statements ("Announcement"). Unless otherwise defined, all terms and references used in this announcement shall bear the same meanings ascribed to them in the Announcement.

As stated in the Announcement, the Waiver by SGX RegCo was to the Company subject to the following conditions:

- (a) the Company announcing the Waiver granted, the reasons for seeking the Waiver, the conditions as required under Mainboard Rule 107 and if the Waiver conditions have been satisfied. If the Waiver conditions have not been met on the date of the announcement, the Company must make an update announcement when the conditions have all been met;
- (b) submission of a written confirmation from the Company that it is not aware of any information that will have a material bearing on investors' decision which has yet to be announced by the Company; and
- (c) the Company announcing its 1H2023 financial statements by 13 October 2023.

(collectively, the "Conditions").

Condition (a) was satisfied on 15 August 2023, following the release of the Announcement.

Condition (b) was satisfied on 11 October 2023, following a submission of a written confirmation to SGX RegCo on 11 October 2023 that the Company is not aware of any information that will have a material bearing on investors' decision which has yet to be announced by the Company in relation to the Waiver.

The release of this announcement and the announcement of the Company's 1H2023 financial statements seeks to satisfy the remaining Condition (c).

Accordingly, as at the date of this announcement, the Conditions to the Waiver have been satisfied.

Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.

Shareholders of the Company and other stakeholders are advised to read this announcement and any further announcements by the Company carefully, and to exercise caution when dealing in the shares or other securities of the Company. Shareholders of the Company and other stakeholders should consult their stockbrokers, bank managers, solicitors, accountants, or other professional advisors if they have any doubt about the actions they should take.
