MONTHLY UPDATE PURSUANT TO LISTING RULE 704(23)

The board of directors of TA Corporation Ltd. (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to inform that since the Company's last monthly update on 1 March 2024 and the following announcements made by the Company:

- (i) on 10 March 2024, in relation to the receipt of a letter of intent from SGUnited Capital Pte. Ltd. ("**SGUnited**") indicating its interest to purchase various units situated in New World Centre ("**New World Properties**") and the Company's application to the Singapore Exchange Regulation ("**SGX RegCo**") to seek waiver from obtaining shareholders' approval to the grant of options to SGUnited to purchase the New World Properties ("**Waiver Application**");
- (ii) on 11 March 2024, in relation to the cessation of Mr. Neo Kian Lee as Site Manager of Sino Holdings (S) Pte Ltd;
- (iii) on 31 March 2024, in relation to SGX RegCo's no objection to the foregoing Waiver Application set out in (i), and
- (iv) on 31 March 2024, in relation to the receipt of a letter of intent from BA Shoppes Pte. Ltd. indicating its interest to purchase various commercial units situated in Ascent@456 ("**Ascent@456 Properties**") and the Company's intention to apply to SGX RegCo to seek waiver from compliance with the relevant listing rule(s) in relation to the proposal disposal of the Ascent@456 Properties,

there have been no further material developments.

Further announcements will be made by the Company as and when there are material developments.

Trading of the Company's securities on the SGX-ST had been voluntarily suspended by the Company on 17 July 2023.
